In producing here with one arrested accused namely Rohan Kumar Ram (29 Yrs) S/O Lt. Lalu Ram of Vill-Arabindapally, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 20 bottles (in sealed condition) DIL SE country spirit, 600-ml each bottle, Rs-55 of each bottle.

2) 08 bottles (in sealed condition) Haywards-5000 Premium Strong beer, 650-ml, Rs-125

I ASI Dulal Singh Sardar of Adra PS do here by lodged a complaint against accused namely Rohan Kumar Ram (29 Yrs) S/O Lt. Lalu Ram of Vill-Arabindapally, PS-Adra, Dist- Purulia to the effect that on 23/02/24 during my evening mobile duty vide Adra PS CC No-505/24 dtd.23.02.2024 at about 19:05 hrs I received a telephonic information from a reliable source that one Rohan Kumar Ram has been stock of country spirit and foreign liquor illegally at his Jhupri at Loco Colony near chatna More. After getting such information I informed to my I/C and as per his direction I along with my accompanied force C/37 Durjan Murmu and NVF/969 Praloy Mahato reached at Loco Colony near chatna More at about 19:35 hrs and hold raid in the Jhupri of said Rohan Kumar Ram and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Rohan Kumar Ram has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Rohan Kumar Ram selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.35 hrs to 19.55 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Rohan Kumar Ram (29 Yrs) S/O Lt. Lalu Ram of Vill-Arabindapally, PS-Adra, Dist- Purulia under proper section of law.

been started.
