1) 20 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-55 of each bottle.

I ASI Rajkumar Nandi of Adra PS do here by lodged a complaint against accused namely Tinku Sahis (48 Yrs) S/O Lt. Tarapada Sahis of Vill-Jyotimore, PS-Adra, Dist- Purulia to the effect that on 26/02/24 during my evening mobile duty vide Adra PS CC No-526/24 dtd.26.02.2024 at about 20:05 hrs I received a telephonic information from a reliable source that one Tinku Sahis has been stock of country spirit illegally at his Jhupri at Jyotimore. After getting such information I informed to my I/C and as per his direction I along with my accompanied force C/522 Ruplal Tudu and C/2907 Sukumar Dutta reached at Jyotimore at about 20:35 hrs and hold raid in the Jhupri of said Tinku Sahis and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Tinku Sahis has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Tinku Sahis selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 20.45 hrs to 21.15 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Tinku Sahis (48 Yrs) S/O Lt. Tarapada Sahis of Vill-Jyotimore, PS-Adra, Dist- Purulia under proper section of law.
