I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Gopeswar Gorain, S/O- Late Laxman Gorain of Village –Beldi, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 16.02.2024 at about 01.35 pm I, along with Partha Chakraborty, S/O- Late Dinobandhu Chakraborty, Divisional Engineer(E), S&LP, Purulia Regional Office, Dayamoy Mahato, S/O- Late Chutulal Mahato, Purulia, Regional Office, and Rajesh Kumar, S/O-Late Gulo Ram, Junior Engineer(E), Gr-I, Arsha CCC went to routine inspection at Beldi Village and enters in premises of Gopeswar Gorain who was enjoying electricity unauthorisedly by direct hooking from nearby LTOH Line of WBSEDCL in his premises. The hooking line of Gopeswar Gorain disconnected on the spot from nearby LTOH Line of WBSEDCL on 16.02.2024. During inspection we found the electrical load he was enjoying as 1.7 KW. The inspection team left the premises of the accused person at about 01.50 pm.

Gopeswar Gorain, S/O- Late Laxman Gorain of Village –Beldi, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i)(a) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
