I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSedcl, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Khagendra Nath Majhi, S/O- Late Kinkar Ch. Majhi of Village –Upar Jambad, PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(i)(b) of electricity act 2003 subsequently amendment act 2007.

On 16.02.2024 at about 03.35 pm I, along with Partha Chakraborty,S/O- Late Dinobandhu Chakraborty,Divisional Engineer(E),S&LP,Purulia Regional Office,Dayamoy Mahato,S/O- Late Chutulal Mahato, Purulia, Regional Office, and Rajesh Kumar, S/O-Late Gulo Ram, Junior Engineer(E),Gr-I, Arsha CCC went to routine inspection at Upar Jambad Village and enters in premises of Khagendra Nath Majhi who was enjoying electricity unauthorisedly by tapping the service main line and bypassing the energy meter of WBSedcl in his premises. The service connection of Khagendra Nath Majhi disconnected on the spot from nearby LTOH Line of WBSedcl on 16.02.2024. During inspection we found the electrical load he was enjoying as 0.585 KW.The inspection team left the premises of the accused person at about 03.55 pm.

Khagendra Nath Majhi, S/O- Late Kinkar Ch. Majhi of Village –Upar Jambad, PS-Arsha,Dist-Purulia has committed an offence U/S 135(i)(b) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
