Dear Sir,

I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Aghnu Mudi S/O- Late Lilu Mudi of Village - Sridi, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 19.02.2024 at about 14:23 o'clock I, along with Gour Chandra Mahato, S/O-Late Bibhuti Mahato, H.G Sr. L.M, Purulia Division and Abhijit Mondal, S/O-Late Abala Mondal, Sr. O.E, Purulia Division went to routine inspection in Sridi Village and entered into the premises of Aghnu Mudi S/O- Late Lilu Mudi of Village -Sridi, PS-Arsha, Dist-Purulia and found that Aghnu Mudi S/O- Late Lilu Mudi was enjoying electricity unauthorisedly by direct hooking from LTOH Line of WBSEDCL in his premises. The hooking connection of Aghnu Mudi S/O- Late Lilu Mudi was disconnected on the spot from nearby LTOH Line of WBSEDCL. During inspection we found the electrical load he is enjoying as 1.53 KW. The inspection team left the premises of the accused person at about 14:35 o'clock.

Aghnu Mudi S/O- Late Lilu Mudi of Village -Sridi, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i) (a) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
