I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Bhonda Majhi of Village –Tilaitar(Kherbera) Near the well, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 22.02.2024 at about 1.30 pm I, along with Gour Chandra Mahato, S/O-Late Bibhuti Mahato, H. G. Sr. L.M, Purulia (D) Division and Chandan Mahato, S/O-Late Phanibhushan Mahato, TSH, Arsha CCC went to routine inspection at Tilaitar(Kherbera) village near the Well and found that Bhonda Majhi was enjoying electricity unauthorisedly by direct hooking from nearby LTOH line of for his agriculture purpose. The hooking line of Bhonda Majhi was disconnected on the spot from nearby LTOH Line of. During inspection we found the electrical load he was enjoying as 0.750 KW. The inspection team left the premises of the accused person at about 01.40 pm.

Bhonda Majhi of Village –Tilaitar(Kherbera) Near the well, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i)(a) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
