To The Officer-In-Charge, Arsha PS, Purulia.

Sir.

In producing here with one arrested accused person Santiram Mahato (38yrs) S/O- Lt. Sakharam Mahato of vill- Hetgugui, P.S.-Arsha, Dist-Purulia along with following seized articles.

- 1) 15 bottle County Spirit marked as Dil Khush, 600 ML each bottle & Rs-55/- each bottle (One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- I, ASI Sisir Kr. Gope of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 23.02.2024 at about 17.05 hrs. during my Spl. mobile duty at Balia Morh under Arsha PS, receive source information over telephone that the above noted accused has been selling Country spirit at Hetgugui village. On receiving the source information I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 333 Sitaram Mahato and C/- 252 Ishan Alam both of SAP 7th BN camp at Arsha PS rushed at Hetgugui village to work out the information vide Arsha PS GDE No. 973 dtd. 23.02.2024. Reaching at Hetgugui village at about 17.45 hrs we fixed-up in the grocery shop of Santiram Mahato (38yrs) S/O- Lt. Sakharam Mahato of vill- Hetgugui, P.S.-Arsha, Dist-Purulia and found that 15 bottles County Sprit marked as Dil Khush, 600 ML each bottle & Rs-55/- each bottle on seeing police, customers fled away. But we were able to apprehend the above noted accused person namely Santiram Mahato (38yrs) S/O- Lt. Sakharam Mahato of vill- Hetgugui, P.S.-Arsha, Dist-Purulia, who was selling Country Spirit which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling Country Spirit. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of that seizure was taken as sample which was also duly labeled. It took time from 18.05 hrs. to 18.25 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 18.35 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Santiram Mahato (38yrs) S/O- Lt. Sakharam Mahato of vill-Hetgugui, P.S.-Arsha, Dist-Purulia and also for arranging its investigation.
