Sub: Lodging of F.I.R of theft of Electricity against Bhagirath Bhagat ,S/o Lt. Brindaban Bhagat at his Domestic premises at Vill.-Suisa, P.S.-Bagmundih and thereby committed an offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir.

This is to inform you that, I Sri Sisir Kumar Das (35), S/O – Banamali Das,D.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Bhagairath Bhagair, S/o Lt. Brindaban Bhagair residing at Vill.- Suisa was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 05.02.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Bhagirath Bhagat at the above mentioned address. He was present at his house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Bhagirath Bhagat.

Also search for local people as witnesses during people gathered there. The premises was a two storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by him and served upon him and held inspection.

During inspection, it was detected that, Bhagirath Bhagat had tampered the energy meter installed at Domestic premises bearing meter No: DDG256653 in the name of Bhagirath Bhagat at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Bhagirath Bhagat was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection and removed the Energy meter bearing SI no: DDG256653 after securing the installation place of the said meter from any imminent danger in future. He was shown the tampered meter but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 1.1KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Bhagirath Bhagat, it is well established that Bhagirath Bhagat was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 01:20PM to 01:40PM today after observing all legal formalities.

It is well evident that accused Bhagirath Bhagat ,S/o Lt. Brindaban Bhagat residing at Vill.- Suisa has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
