Sub: Lodging of F.I.R of theft of Electricity against Chittaranjan Kumar, S/o Lt. Rakhal Chandra Kumar at his Domestic premises at Vill.-Jhabri, P.S.-Bagmundi and thereby committed an offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Sisir Kumar Das (35), S/O – Banamali Das, D.E. & Station Manager of Bagmundi CCC of WBSEDCL received an information to the effect that Chittaranjan Kumar, S/o Lt. Rakhal Chandra Kumar residing at Vill.- Jhabri was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 15.02.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Chittaranjan Kumar at the above mentioned address. His brother was present at house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Chittaranjan Kumar.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a two storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared which his brother refuses to sign served upon him and held inspection but Inspection sheet and seizure was signed.

During inspection, it was detected that, Chittaranjan Kumar had tampered the energy meter installed at Domestic premises bearing meter No: L3056338 in the name of Chittaranjan Kumar at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Chittaranjan Kumar was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit disconnected the above mentioned service connection and removed the Energy meter bearing SI no: L3056338 after securing the installation place of the said meter from any imminent danger in future. Barun Chandra Majhi i.e. his brother was shown the tampered meter but being asked he could not render any satisfactory explanation. He was informed about the offence committed by his brother and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in his presence and witnesses at the spot and load assessed as 1.59KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Chittaranjan Kumar, it is well established that Chittaranjan Kumar was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 02:45PM to 03:10PM today after observing all legal formalities.

It is well evident that accused Chittaranjan Kumar, S/o Lt. Rakhai Chandra Kumar of Vill.-Jhabri has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
