In producing here with one arrested accused person namely Sujan Sahis (62 yrs approx) S/O- Lt. Pandab Sahis of Vill- Dhakibaid (Bardih), P.O- Baraurma, P.S.- Balarampur, Dist- Purulia along with following seized articles -

- 1) 22 Ltrs(Approx) of country spirit contained in a plastic container
- 2) 200 grms(Approx) NISHADAL,
- 3) Fifteen pieces of Plastic glass
- 4) Sell proceed of Rs. 175/-

I SI Gour Hari Ghosal of Balarampur P.S. do here by lodge a complaint against accused person namely Sujan Sahis (62 yrs approx) S/O- Lt. Pandab Sahis of Vill- Dhakibaid (Bardih), P.O- Baraurma, P.S.- Balarampur, Dist- Purulia to the effect that today (13.02.2024) at about 16:35 hrs. in course of evening mobile duty I received a telephonic information from a reliable source that the accused person Sujan Sahis (62 yrs approx) S/O- Lt. Pandab Sahis of Vill- Dhakibaid (Bardih), P.O- Baraurma, P.S.- Balarampur, Dist- Purulia stocked country spirit illegally and selling the same to hike price for his personal gain then I informed the matter to O/C Balarampur PS and as per order of O/C Balarampur PS myself along with force rushed to the spot to conduct raid by Govt. vehicle. At about 17:25 hrs myself along with force reached at village- Dhakibaid (Bardih) and held raid and found that the accused person were mixing the country spirit, contained in a plastic container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his house and seeing the police party some person fled away but police party anyhow managed to apprehend above noted 01 (one) accused person and detained him. I asked him about the white powder like substance and accordingly, detained accused person recognized it as "NISHADAL"(approx 200 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person as well as witnesses.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accused person namely Sujan Sahis (62 yrs approx) S/O- Lt. Pandab Sahis of Vill- Dhakibaid (Bardih), P.O- Baraurma, P.S.- Balarampur, Dist- Purulia and arrange for its investigation.
