Brajalal Gorai of Vill- Bhikhari Cheliama, P.S- Barabazar, Dist- Purulia along with seized 1) 30 bottle country sprit style as 'DIL SE' each bottle containing 600 ML & 2) 09 (nine) no of Glass sealed bottle "King fisher Imperial Strong Beer" 650 ML of each bottle, 3) 01 plastic bottle as sealed condition having MCDowell's No-1 celebration matured XXX RUM 750 ML, 4) One TVS XL100 Comfort Golden colour motorcycle bearing registration No- JH05CW/5567 (details of seized articles are mentioned in attached seizure list), I beg to submit that today (24.02.2024) at about 14:15 hrs. in course of my mobile duty I received a credible source information that one Hariram Gorai (61 yrs) S/O-Brajalal Gorai of Vill- Bhikhari Cheliama, P.S- Barabazar, Dist- Purulia is selling ID liquor without any valid license from Kurni village area, P.S-Balarampur, Dist.-Purulia. Accordingly, I informed O/C Balarampur PS regarding this matter and as per his direction I along with force left for Kurni village area to work out the information. Thereafter as per source at 14:25 hrs we reached at Kurni village area and found one person is selling some liquor to local villagers which was kept in bags attached to his motorcycle.
