Respected Sir,

In producing herewith one arrested accused person namely Karmu Mahato (29Yrs. approx), S/O- Khudiram Mahato of Village + P.O + PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46A(C) B.E. Act 1909 with the seized articles i.e.(1) 17 bottles of Mc. Dowell's No-1 Luxury Premium Whiskey each price 180.00 Rs/- containing 180 ml each bottle, (2) 04 bottles of Mc. Dowell's No-1 Luxury Premium Whiskey each price 340.00 Rs/- containing 375 ml. Each bottles & (3) 04 bottles Mc. Dowell's No-1 celebration matured XXX Rum each price 150.00 Rs- containing 180 ml. each bottle. I beg to submit that on 02/02/2024 at about 19.15 hrs. I received a credible source information while I was engaged in Mobile duty that one person namely Karmu Mahato, S/O- Khudiram Mahato of Village + P.O + PS- Bandwan, Dist- Purulia is stocking and selling Foreign liquor without any valid license from his house cum shop at Bombay Chawk at Village + P.O + PS- Bandwan, Dist- Purulia. Accordingly, myself along with C/788 Rabindranath Baidya & C/751 Pabitra Patar all of Bandwan P.S., Dist-Purulia vide Bandwan P.S. C.C. No. 406/24 Dtd: 02/02/2024 with Govt. vehicle left for above noted place to work out the said source information and also called SI Suvajit Nandi and ASI Suman Kr. Basu to assist me and held raid at the house cum shop of Karmu Mahato at 19:45 hrs where the above mentioned accused person has stocked Foreign liquor for selling. Being asked, he disclosed that whole quantity of Foreign liquor has been stocked for the purpose of selling. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Foreign liquor. Accordingly, I seized all the Foreign liquor (details in attached seizure list) in between 20:05 hrs to 20:20 hrs and prepared proper seizure list duly signed by the witnesses. I tried to have signature of local public witnesses in the seizure list but no one agreed to do that. Then, I arrested him at 20:25 hrs, prepared arrest memo as per his revealed identity as noted above maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court and took him to PS and put in lock up maintaining all Hazat rules..

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Karmu Mahato (29Yrs. approx), S/O- Khudiram Mahato of Village + P.O + PS- Bandwan, Dist- Purulia and arrange for its investigation.
