Dear Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Shraban Murmu, S/o – Matilal Murmu, Vill – Katgora, PO - Kuilapal, PS – Bundwan, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 16/02/2024 about 13:35Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Maruti Mahato, Jr Engineer-Gr-I, Bundwan CCC, WBSEDCL and Md. Majam Ali Ansari, Hg-TSH, Bundwan CCC, WBSEDCL visited the premises of Shraban Murmu, S/o – Matilal Murmu, Vill – Katgora, PO - Kuilapal, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection it was found that he was using electricity dishonestly by using black color service cable connection with LTOH line fuse unit which is present at Transformer Kiosk, by means of Direct Hooking.

From the above arrangement he was using the following electrical equipment's:

- 1) TV – 1 Nos, 2) Bulb – 3 Nos, 3) Tube light – 1 Nos, 4) Fan – 1 Nos

Out of which I seized the following:

- 1) Black colour service cable of approx. 30 mtr.

Seizure list was prepared at the site and accused person has been signed.

The inspection team left the premises at 14:20 Hrs pm on 16/02/2024.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as an F.I.R. and action may be taken as per rule.
