Sub: Complain against Akshay Bed (Male /24 Yrs), S/O- Bablu Bed of Village- Harmasra, PS- Taldangra, Dist- Bankura to start a Specific Case U/S 46A(c) Bengal Excise Act. 1909.

Respected Sir,

In producing herewith one arrested accused person namely Akshay Bed (Male /24 Yrs), S/O- Bablu Bed of Village- Harmasra, PS- Taldangra, Dist- Bankura with the seized articles i.e. **1) approx 10 (Ten) litres illicit distil liquor in 01 (One) jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in one separate bottle from mother quantity as sample marked as Exhibit "C"**. I beg to submit that on 16/02/2024 at about 17:45 hrs. I received a credible source information while I was engaged in Evening Mobile duty that one person namely Akshay Bed, S/O- Bablu Bed of Village- Harmasra, PS- Taldangra, Dist- Bankura is selling Illicit Distill liquor (CHOLAI MOD) without any valid license at the backside (North Side) of Bandwan Bus stand under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/233 Upananda Das and C/3195 Pintu Shaw both are of Bandwan P.S, Dist-Purulia left for Bandwan Bus stand to work out the said source information and held raid in the backside (North Side) of Bandwan Bus stand where the above mentioned accused person was selling Illicit liquor. During search with the help of accompanying force, we found that the above noted person is standing at a corner at the back side of the Bus Stand with a jerican with approx 10 liter Illicit Distill liquor for selling. Being asked, he disclosed his identity and stated that he resides at Vill- Harmasra under Taldangra PS, Dist- Bankura and he goes different places under Khatra sub-division of Bankura District and Manbazar sub-division of Purulia district everyday with the container filled with Illicit distilled liquor for the purpose of selling and sells from a suitable static point . On demand, he failed to produce any valid documents/ License in respect of selling of Illicit Distill liquor. Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e **1) approx 10 (Ten) litres illicit distil liquor in 01 (One) jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in one separate bottle from mother quantity as sample marked as Exhibit "C" as produced by the said accused Akshay Bed** from 19:15 hrs to 19.35 hrs and prepared proper seizure list duly signed by the witnesses. Then, I arrested him at 19:45 hrs maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide line and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(c) Bengal Excise Act. 1909 against the arrested accused person namely Akshay Bed (Male /24 Yrs), S/O- Bablu Bed of Village- Harmasra, PS- Taldangra, Dist- Bankura and arrange for it's investigation.
