I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that NABAKISHORE SOREN S/O NAGEN CHANDRA SAREN VILL – KHERYADIH (FULHORE), Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- 7S0274197) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 06.02.2024, I Sri Banti Karmakar, A.E.&S.M, BARABAZAR CCC, WBSEDCL along with

At About 3:30 P.M., entered into the premises of NABAKISHORE SOREN S/O NAGEN CHANDRA SAREN VILL – KHERYADIH (FULHORE), Dist- Purulia and inspected his premises .

while doing inspection at the premises that NABAKISHORE SOREN S/O NAGEN CHANDRA SAREN VILL – KHERYADIH (FULHORE) in presence of NABAKISHORE SOREN , we found that the accused one was using electricity by means of by passing the meter consumption with the help of 2 core 6 square mm PVC Cable in his premises at VILL – KHERYADIH (FULHORE) having connected load 1.2 KVA.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 3:50 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.
