I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that HAZRAT ANSARY of Vill- ARABAID, P.S- Barabazar, Dist- Purulia, has committed theft of electricity U/S 135(1)/e of electricity act 2003 subsequently amendment act 2007.

On 06.02.2024 at about 5:15 P.M. I Sri Banti Karmakar, AE & Station Manager, Barabazar CCC along with 01. Shibaji Chakraborty, JE(E) GR-II, Barabazar CCC, 02. Sanjit Mahato, Sr. T.S.H Barabazar CCC entered the premises of HAZRAT ANSARY of Vill- ARABAID, P.S- Barabazar, Dist- Purulia and found HAZRAT ANSARY, was supplying the electricity from his existing defective meter (1026344) in an un authorized way to nearby another premises for construction of building with the help of low quality local wire of 12 meter approx and connected load found 750 watts. As that of HAZRAT ANSARY committed theft of electric power. So, I Seized the following articles after preparing the seizer list in presence of 01. Shibaji Chakraborty, J.E GR II. BARABAZAR CCC, 02. Sanjit Mahato, Sr. T.S.H., Barabazar CCC. The inspection team left the premises at 5:40 P.M
