Sub: Complaint against Akshay Singh Sardar (35 Yrs) S/o Lab Sing Sardar @ Bauri Sing Sardar of Vill-Barabazar Raidih, PO-Berada, PS-Barabazar, Dist-Purulia to start a specific case under proper section of Law.

Sir,
In producing here with one arrested accused person namely Akshay Singh Sardar (35 Yrs) S/o Lab Sing Sardar @ Bauri of Vill-Barabazar Raidih, PO-Berada, PS-Barabazar, Dist-Purulia along with Memo of arrest, Seizure List, Check List and seized article i.e- Two white colour Plastic Jerkin containing approx 22 (Twenty Two) liters of I.D liquors (Cholai) from which 500 ml ID Liquor (Cholai) seized as sample in a plastic bottle from the mother contraband.

I, SI Mukul Karmakar of Barabazar PS do here by lodge this complaint against Akshay Singh Sardar (35 Yrs) S/o Lab Sing Sardar @ Bauri Sing Sardar of Vill-Barabazar Raidih, PO-Berada, PS-Barabazar, Dist-Purulia, to the effect that on today (07.02.2024) during my spl. mobile duty vide Barabazar PS GDE No- 384 Dtd. 07.02.2024 and C.C. No. 645 Dt. 07.02.2024 received a source information that one person unauthorized keeping & selling I.D liquor (Cholai) in front of his house at Raidih village under Barabazar PS, Dist- Purulia. After receiving the said information to verify myself along with ASI Rabindranath Mandal, C/897 Umapada Dhalla & C/1187 Samar Kanta Maity all of Barabazar P.S, Dist-Purulia had been to the spot to the credibility of that information and direction of I.C Barabazar PS reached at about 18.05 hrs found one person was keeping & selling I.D liquor (Cholai). When we reached in front of said place, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Two white colour Plastic Jerkin containing approx 22 (Twenty Two) liters of I.D liquors (Cholai) and selling from that place. On demand, he failed to produce any valid documents / License in respect of keeping & selling of I.D liquors (Cholai). On being asked he disclosed his identity & confessed his guilt and stated that he selling the ID liquors (Cholai) with intent to sell to make own profit. He also admitted that he had no license or any authorization to keeping and selling of ID Liquor. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 500 ml of I.D liquor (Cholai) taken as sample from the mother contraband which was also duly labeled and also took signature of the accompanying witnesses as well as accused person on seizure list and label also. The seizure and label was done in between 18:25 hrs to 18:45 hrs.

Thereafter, I secured arrest of the accused Akshay Singh Sardar (35 Yrs) S/o Lab Sing Sardar @ Bauri Sing Sardar of Vill-Barabazar Raidih, PO-Berada, PS-Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. Arrest was made on 07.02.2024 at 18.50 Hrs. I asked the local people as witnesses but none turned up. Held an enquiry about the matter.

Under the above fact & circumstances I, therefore, pray before you that as per law a specific case may kindly be registered against Akshay Singh Sardar (35 Yrs) S/o Lab Sing Sardar @ Bauri Sing Sardar of Vill-Barabazar Raidih, PO-Berada, PS-Barabazar, Dist-Purulia and also for arranging for its investigation.
