

That Upasi Sabar is the legally married wife of the complainant and the marriage has been performed before 20/21 years back and due to that wellock one daughter and a son







has been born who are aged about 19 years and 17 years respectively and both the child familor in the locality namely Mamoni Sabar and Barid Sabar.

- 21 That on 25th November 2023 your complainant went out another village for his daily work and by taking advantage of the same one Nibaran Mahato s/o late Durjadhan Mahato of Vill.Biskudra, P.S.Barabazar, at about 4.p.m.enter into how house and forcefully abducted wife and taken her from the outside at the house.
- 3) That your petitioner's daughter and son raised objection for such illegal work of the accused but accused did not pay any heed.
- 4. That as and when your petitioner return home at evening son and daughter informed the matter to your petitioner and then your petitioner tried to search out on the locality as well as in the out side of his village and on the following day after several good attempt as and when he fails to search out his wife than he informed the matter to the police station, but of no good.
- 5. That thereafter on various occasion your petitioner tried to search out at various places but all in vain.
- 6. That after two weeks from such incident a telephone call from number 8101053298 inform to your petitioner that his wife Upasi Sabar has been abducted and kind kidnapped as well as confined forcculty at village Eurudi, Dist.Sarai-kela, Jharkhand and the accused demanding Rs. 100000/-



as ransom otherwise the accused killed the victim lady, if the demand will not fulfill.

- 7. That thereafter your petitioner also informed the matter to the P.S. as well as S.P. Purulia but all in vain.
- 8. That your petitioner/complainant is very poor man belongs to S.T. community and there is all possibility to recover my his wife by interference of police and to punished the criminal.
- That your petitioner/complainant have no other alternative but to take shelter u/s.156(3)Cr.P.C.

It is therefore prayed that your Honour may graciously be pleased to send this petition of complaint before O/C Barabazar after treating this as a F.I.R. for investigation and necessary legal to the step.
