

FIRST INFORMATION REPORT

To The Inspector In-Charge Barabazar Police Station Dist- Purulia

Sub: FIR

Sir,

In producing here with the arrested accused person namely Sambhu Mahato @ Mota (20 yrs) S/o Lakhikanta Mahato of Vill-Taladih, PS-Barabazar, Dist-Purulia driver of Dumper having registration No- WB49-0302 and brought under seizure 01 Dumper having Reg. No WB49-0302 loaded with approx 19 (nineteen) M.T. black stone and from which seized 2 Kg black stone as sample under proper seizure list.

I beg to state that during mobile duty at PS area along with C/1494 Manas Mukherjee & C/347 Manas Pathak both are of Barabazar PS left PS to verify the information vide Barabazar PS GDE No- 1259 Dtd. 22.02.2024 and Spl. C.C No- 88/24 Dtd. 22.02.2024 with Govt vehicle received a source information that illegal transporting of black stone loaded with Dumper which was coming from Laka to Sindri Side via Pitch road. I communicated the matter to I.C Barabazar PS and as per direction myself along with accompany force left for Sindri-Laka Road to work out the information. Reached at about 13:50 hrs beside Bio-Diversity Plant near Ram Mandir at Sindri village under Barabazar PS, Dist-Purulia and after few minutes later found that one Dumper is coming from Laka Side with high speed. I along with force able to stopped the vehicle (Dumper) having Reg. No WB49-0302 and found that the vehicle is loaded with black stone, measuring weight approx. 19 M.T.. On asked the driver disclosed his identity as noted above and also I asked him to produce the valid documents in r/o loaded black stone but he was unable to produce any valid documents regarding the transporting of the black stone in his said dumper.

Accordingly, I seized the above noted vehicle having Reg. No WB49-0302 (Dumper) loaded with black stone approx. 19 M.T. and from which seized 2 Kg black stone as sample under proper seizure list duly signed by the witnesses. After that I arrested the accused driver as noted above after maintaining all formalities regarding arrest. I also informed him regarding the grounds of arrest and informed his relative.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the vehicle (Dumper) having Reg. No WB49-0302 collected the black stone by illegal means with intend to make unlawful profit by unlawful collection of black stone through illegal manner by unauthorized extraction and removal of minerals.

By this way they committed the theft of minerals. As such there is every reason to believe that the driver and owner of the Dumper with ill motive were transporting the black stone illegally without any valid document in support of carrying the stone. As such they were doing illegal business activities.

After returning at PS, I prepared this letter of complaint and brought the arrested said accused person along with black stone loaded dumper and handing over it to I.C Barabazar PS for starting a case under proper section of law and also arrange its investigation.
