



The humble petition of the complainant most respectfully begs to state: That on 02-12-2023 at about after the evening I and my other members of my family namely Phulbani bibi, Maneja bibi, Sabja Khatun, Sk Samrul in the morning we all went to purulia court and we attended the court and it took much time to complete the court work we were returning to our village by a minibus and alighted from the bus in the evening when there was dark to some extent prevailed and we all above said persons were proceeding towards our village, at that time about 10/12 persons gharoud us among the crowd we could recognize 1) Sk. Nazimuddin son of Sk. Ismile 2)Jarina Bibi wife of Sk. Nazimuddin 3)Sk.Abul Hussion son of Sk. Sahid 4)Masudan Bibi wife sk. Abid 5)Sk. Ismile son of late Sk. Samad of village jambad they started to tell us that we have started false case against you and now we shall murder you after assault. We became very much fearful and they all started to assault us by hand and other dangerous weapon. Abul Hussion and Sk. Ismile caught hold on me and sk. nazimuddin snatched Rs.50,000/- from my inside pocket of the shirt and sk. Nazmuddin and Abul Hussain snatched away one pair of golden Eardul, one pair of golden neck chain and one pair of silver Bangle the cost of which would be about rupees 1,43,000/-.

It is mentioned that for purchasing articles for the marriage of my youngest daughter Sabja khatun we took the money but as our court case took much time for which I could not purchase those marriages articles and I was carring the money back with hope to purchase on the following day. At the time of occurrence some person gathered among whom there was there was sk. sajibul son of Sk. Jamal Sk. sahid son of late sk. Adhar they witnessed the occurrence. After assaulting us and snatching the money and ornament the miscreants fled away.

Thereafter I filed complaint before the officer-in-charge of Hura police station but the police officer on duty did not record my case for which I sent the complaint by registered post on 13/12/2023 but still now the officer-in-charge of Hura P.S. has not taken any action against the culprits. I sent the complaint along with a forwarding letter to the superintendent of police purulia on 13-12-2023 but no action yet has been taken against the miscreants for which I have filed this complaint and pray that the complaint may kindly be sent to the officer-in-charge of Hura police station to start case and investigate and report U/S-156(3) Cr.P.c.

It is mentioned that the offence committed by the miscreants are all cognizable and serious in nature and there is a chance of recovery of the stolen money and ornaments moreover the complainant is a poor man and has no such sufficient means to conduct the case of his own.
