Sub: - Complaint against Chitta Mahato (57 yrs.) S/O- Lt. Pitambar Mahato of Vill- Hura Keshabpur (Bagandih), PS- Hura, Dist- Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Chitta Mahato (57 yrs.) S/O- Lt. Pitambar Mahato of Vill- Hura Keshabpur (Bagandih), PS- Hura, Dist- Purulia along with seized Country Spirit bottles DIL SE (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 09.02.2024 during my Spl. Mobile duty at 16.45 hrs. received a credible source information from my reliable source that the above noted accd. person was stoking and selling Country Spirit at Hura Keshabpur (Bagandih) village. Accordingly I informed O/C Hura PS and left for work out that information. After reaching to spot along with force and held raid in between (17.15 hrs. & 17.45 hrs) in the house of above noted accused person at Hura Keshabpur (Bagandih) village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his house at Hura Keshabpur (Bagandih) under Hura PS, Dist Purulia, On demand, he failed to produce any valid documents/License in respect of selling and stocking Country Spirit. Accordingly, I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest as he committed offence U/S 46A(c) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Then I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. Total 13 (Thirteen) Plastic bottles DIL SE measuring 600 M.L. each bottles have been seized.

Under the above fact circumstances and, I therefore pray that a Cog Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person namely Chitta Mahato (57 yrs.) S/O- Lt. Pitambar Mahato of Vill- Hura Keshabpur (Bagandih), PS- Hura, Dist-Purulia and arrange for its investigation.
