Sub: - Complaint for lodging FIR.

Sir,

I, ASI Rabin Mukherjee of Hura PS do hereby submit complaint against the arrested accused person namely Sk. Manjur Chalak (35 yrs.) S/O- Lt. Sk. Samsul of Vill- Hutmura, PS- Purulia (M), Dist- Purulia to the effect that today on 22.02.2024 during day mobile duty vide Hura PS GDE No- 954 dtd- 22.02.2024 on Purulia-Bankura road at about 15.15 hrs I, received a telephonic information from a reliable person that a vehicle loaded with cow were coming from Bankura side without any valid documents or proper permission from concern authority. The matter was intimated to O/C Hura and as per his kind instruction I along with my accompanied force C/3001 Debasish Mondal, HG/1449 Mithun Majhi both of Hura PS rushed to near Ladhurka morh on NH 60A at about 16.05 hrs. I managed to stop the vehicle bearing Reg. No. WB 55A/4520 (Pick-up Van) and found that Total Cattle 05 (five) like Cow & Calf were loaded in the vehicle (details are mentioned in the attached seizure list).

On being asked, he revealed his identity as noted above but his identities could not be verified as he could not produce any relevant document in respect of their address and age. On demand, he could not produce any papers in respect of the vehicle or the Cattles, and about the procurement of the cattle or vehicle. Not only that he has not any paper regarding transportation of the Cattle etc. The vehicle is not meant for transporting livestock as no livestock permit was available. He did not give satisfactory reason for transporting of Cattle by vehicle. He has stated incoherently and from his statement there is every reason to believe that he has procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. He discloses the name of the persons who were involved in this conspiracy namely 1) Babu @ Sk. Babu S/O- Sk. Ekrar, 2) Lelu @ Sk. Muslim S/O- Lt. Sk. Khalil, 3) Sk. Siddik S/O- Sk. Ramjan all of Vill- Jambad, PS- Hura, Dist- Purulia. Moreover, he was carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accused person treated the cattle in such a manner so as subject those to unnecessary cruelty as he loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized Total 05 (five) Cattle and the vehicle noted above from the possessions of the above noted accused person under proper seizure list and after seizure I also arrested him as he committed offence U/S- 379/411/414/120B IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accused person by maintaining all formalities regarding arrest with the help of my accompanied force. The vehicle is not meant for transporting the cattle also.

I, therefore pray that a case may kindly be started against the arrested accused person noted above, who is also the owner of the vehicle No- WB 55A/4520 and 1) Babu @ Sk. Babu S/O- Sk. Ekrar, 2) Lelu @ Sk. Muslim S/O- Lt. Sk. Khalil, 3) Sk. Siddik S/O- Sk. Ramjan all of Vill- Jambad, PS- Hura, Dist- Purulia U/S- 379/411/414/120B IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
