



In the matter of a complaint u/s156 (3) of Cr.P.C. on behalf of the Petitioner/ Complainant namely Chandicharan Mahato.



Most respectfully begs to state:-

- 1...That the complainant and the accused persons are resident of village + P.O. Kulgora, under P.S. Hura, District- Purulia (W.B) and within the jurisdiction of this Ld. Court.
- 2...That on 22/01/2023 while the son of complainant namely Sandip Mahato returning home late after appeared an examination and when he got down from the vehicle at Kulgora More around 9.30 P.M. suddenly the above named accused person attacked him with a common intention to kill him.





- 3...That the accused persons are started to physically assault the son of the complainant mercilessly as a result he sustained bleeding cut injury in his right eye, the son of the complainant Sandip Mahato rescued by some of the witnesses and rushed to Hura BPHC, where the son of the complainant got primary treatment and two stitches has to be done in his right eyelids. The attending Doctor of Hura BPHC referred my son to Purulia Medical College and Hospital for his better treatment and managements and the son of the complainant immediately admitted to the Purulia Medical College and Hospital situated at Hatuara, Purulia.
- 4...That the accused persons till now giving threat to kill the son of the complainant as he narrowly escaped from the clutches of the accused persons.
- 5...That That the complainant on the same day visited Hura P.S. to lodge written complaint against the accused persons but the officer on table asked them to go for medical treatment first and thereafter lodge written complaint before the concerned Hura P.S.
- 6...That as the Complainant was busy for treatment of his son as such he went to Hura P.S. on 25/01/2024 morning for lodging written complaint but the duty officer on table refused to receive any written complaint against the accused persons and advise the complainant to settle the dispute with the accused persons.
- 7...That as the officer of Hura P.S refused to receive the written complaint against the accused persons the complainant on the same day i.e. on 25/01/2024 send his written complaint to the O.C Hura P.S through registry post post but till today no action has been taken against the accused persons and they are roaming freely and also threatening the complainant and his family members. So the complainant and his family members are passing each of every day out of fears and mental agony.
- 8...That 01.02.2024 the Complaint inform the matter to the S.P. Purulia but till date no action has been taken against the accused persons as such having no other alternatives your Complainant filing this Misc. Petition u/s 156(3) of Cr.P.C. before this Ld. Court.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition filed u/s 156 (3) of Cr.P.C. and treating the same as a F.I.R. be pleased to send it to Hura P.S. with a direction to proper Investigation and necessary steps against the accused person as alleged in the petition by the Complainant.
