I, SI Surajit Kumar Das of Jhalda PS, Dist-Purulia do hereby lodge this complaint to the effect that today on 02/02/24 at 15.55 hrs, in course of performing Naka checking duty at Bartal morh under this PS along with ASI/08 Tapan Kr Mahato, Constable 1353 Atanu Ganguly and

Constable 814 Sushabhan Goswami vide Jhalda PS CC No 727/24 dtd 02/02/24 and GDE No 87, dtd 02/02/24, I received a credible source information that huge quantity of opium will be transported by a lorry having number HR65A/2149 through Ranchi – Purulia road . It is already on way from Ranchi side to Jhalda side and it will reach Jhalda market within 45 to 50 minutes. Accordingly, I informed the matter to you from my phone to your's phone having no 9147888757 and as per your kind direction, the duty officer diarized it in PS GD, vide Jhalda PS GDE No 89, dtd 02/02/24. I also started arranging cameraman, public witness and other necessary investigation logistics such as weight machine, seal–pack-level related articles as well as laptop and printer. I also briefed my accompanying force about the information and further course of action. Meanwhile IC Jhalda mailed BDO, Jhalda for being present as Executive Magistrate during search and seizure process if needed as well as SDO Jhalda also phoned BDO Jhalda, to make him aware of the mail for prompt action. I was able to convince (i) Maheswar Singh Sardar (21 yrs) S/O- Gangadhar Singh Sardar of Vill- Chekya, PS- Kotshila, Dist- Purulia & (ii) Shantiram Kumar (21 yrs) S/O- Chhutubabu Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia to stand as witness during seizure process and they wilfully agreed. Local public videographer was also managed.

At 16.51 hrs, we intercepted the said vehicle in which there was none except the driver. We cordoned it and immediately informed to you about it. As per my direction, the driver got down from the vehicle. I identified myself as police officer of Jhalda PS by showing my identity card and informed him the ground of detaining him with the vehicle. I started interrogating him and in course of interrogation, he disclosed his identity as noted above. In course of interrogation, at 17.25 hrs you reached there and also joined the interrogation. At first the said driver tried to mislead police, but after all he confessed that he was carrying opium poppy straw by the vehicle noted above. On demand he failed to produce any relevant paper in respect of loaded articles in the vehicle. At 18.45 hrs BDO, Jhalda reached at the spot. Subsequently I requested him to co-operate and also introduced him with the witnesses as well as BDO, Jhalda as Executive Magistrate. I then served written notice upon the detained person U/s 100 Cr.P.C. and explained the content of notice in the language he can understand i.e. Hindi-stating that he has the right to search all the police personnel and witness prior to searching him of his belongings and vehicle. He replied positive and searched all the police personnel, Gazetted Officer and witness and found nothing relating to Narcotic drug and substances except our personal belongings. Then, I prepared a nil search list duly signed by the Police party, witnesses and the detained person.

After that, I explained the detained person regarding the provision of section 50 of the NDPS Act, 1985 (as amended) in presence of the said witness and served notice upon him and he had legal right to be searched in presence of magistrate. After that I have started search procedure of the detained person as well as the vehicle in presence of Insp Sri Shib Sankar Singha, IC Jhalda PS and Sri Madan Mohan Murmu, WBCS (Exe) BDO, Jhalda Dev Block. The search and seizure process was started at 19.05 hrs arranging sufficient light. No objectionable article was found from his person during search of his body. After that we start searching of the vehicle and found 29 numbers of nylon bag (Basta). Each nylon bag contains same type of substance which he identified as opium poppy straw. We started weighting and seizing those bags one by one with proper seizure list duly signed by witnesses as well as BDO Jhalda and you and all the bags were individually labelled. Beside this, 137

Pieces of empty fruit tray were seized from the said vehicle as well as one Registration Certificate issued by Govt. of Haryana in favour of the Truck having Registration No. HR65A/2149 in the name of Roshan Lal S/O- SH Chunni Lal of Dera Rampur Khera, Sirsa (17) Kurukshetra, HR 136128, valid up-to 07/04/2024 and One Driving license issued by Licensing Authority Karnal having License No. HR0520130124029 in the name of Kuldeep Singh (D.O.B- 08/09/1977) S/O- Savinder singh of Vill-Bansa, Dist- Karnal, 132001 valid up to 07/09/2027 were seized from the possession of above noted Kuldeep Singh. Lastly, the vehicle was also seized. The seizure process was done from 19.05 hrs to 21.15 hrs under proper videography. After seizure I arrested him observing all the formalities of arrest. It is noted here that I took signatures of all the witness, and the arrested person in all the labels of seized articles which were recovered and seized from his possession and marked accordingly.

I therefore pray before your good office to kindly register a specific case against the accused person namely Kuldeep Singh (46 yrs), S/O- Late Savinder Singh of Vill – Bansa, PS – Nissing, Dist – Karnal, Haryana U/S 15 (c) NDPS Act 1985 and arrange for its investigation.
