Sir,

I, ASI Thakurdas Kalindi along with force return to PS and brought under seizure One Red colour tractor without number plate, Chassis no-MBNTFAEDBPRC03114 & Engine no-RPC7EBN0796 styled as Mahindra 275 DI SP plus attached with trolley loaded with sand (approx 90 cft). The fact in brief is that today (08/02/2024) I along with force namely i) NK/1699-Ramesh Pradhan & ii) RM/1449-Sanjit Saibo were performing Spl. night mobile duty at Jhalda PS area vide Jhalda PS GDE No- 450 Dated- 08/02/2024 in consonance with Jhalda PS CC No- 809/24 Dated- 08/02/2024. During my Spl. night mobile duty at 23:00 hrs I received a credible source information that one Red colour Mahindra Tractor is coming from Ichag side towards Jhalda along old Bagmundi road. Subsequently, I informed you and as per your kind order, I placed Naka at Gokulnagar more under Jhalda PS, Dist-Purulia to work out this tip off and started Naka Checking after placing proper guard rail on the road. Thereafter I saw the one tractor was proceeding towards Jhalda side along old Bagmundi road. Consequently, we intercepted the said Tractor before Naka checking point on 08/02/2024 at about 23:15 hrs. and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, the driver of the said Tractor fled away leaving the Tractor on road before Naka checking point at Gokulnagar more under Jhalda PS, Dist-Purulia. We tried to chase him but in vain. After that we searched the said Tractor for valid documents but did not find any valid documents in respect of loaded sand in the tractor. We also waited for some times but nobody came. Hence I seized the said Red colour tractor without number plate having Chassis no-MBNTFAEDBPRC03114 & Engine no-RPC7EBN0796 styled as Mahindra 275 DI SP plus attached with trolley loaded with sand (approx 90 cft) under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractor to Jhalda P.S. As such there is every reason to believe that the driver and owner of the Red colour tractor having Chassis no-MBNTFAEDBPRC03114 & Engine no-RPC7EBN0796 styled as Mahindra 275 DI SP plus attached with trolley are transporting sand illegally without any valid document in clandestine manner.

Therefore, I pray before you that a case against the driver and owner of the red colour tractor having Chassis no-MBNTFAEDBPRC03114 & Engine no-RPC7EBN0796 styled as Mahindra 275 DI SP plus attached with trolley may kindly be started under proper section of law and arrange for its investigation.
