Sir,

I, ASI Thakurdas Kalindi along with force return to PS and brought under seizure One Red colour tractor Reg. number WB55B0873, Mahindra B-275DL, Chassis no-MBNABAEXPKRB06989 & Engine no-RKB2EAN1125 attached with trolley loaded with sand (approx 90 cft). The fact in brief is that today (21/02/2024) I along with force namely i) C/1221-Yudhisthir Kumar & ii) C/955-Dilip Kr. Mandal were performing Spl. Evening mobile duty at Jhalda PS area vide Jhalda PS GDE No- 1079 Dated- 21/02/2024 in consonance with Jhalda PS CC No- 940/24 Dated- 21/02/2024. During my Spl. Evening mobile duty at 17:45 hrs I received a credible source information that one Red colour Mahindra Tractor is lifting sand from the bank of river Subarnarekha near Shyamnagar Bridge under Pusti GP as well as Jharkhand Border. Subsequently, I informed the matter to I/C Jhalda PS and as per your kind order, I left out to work out the information. I was proceeded to Pusti GP to verify the work out the information as per direction of I/C Jhalda PS. Accordingly, we arrived at 18:25 hrs the bank of river of Subarnarekha near Shyamnagar ghat (Jharkhand Border) and found one tractor and some persons lifting sand on their tractor. We the police party tried to check the facts whether they are having legal permissions or not but on seeing police party the persons running here and there. Finally, no one was claimed as well as none approached to us for its legal ownership. Thereafter I seized the vehicle after maintain all legal formalities.

During local enquiry it came to learn that the following persons are involved the illegal sand lifting and transporting in the area (1) Bijoy Kuiry S/O Dhananjoy Kuiry of Village-Hesla, P.O- Karmadih, P.S-Jhalda, Dist- Purulia (2) Aranya Mahato S/O Ajit Prasad Mahato of Village-Durgu, P.O- Pusti, P.S-Jhalda, Dist- Purulia (3) Swapan Kuiry S/O Gutil Kuiry of Village- Hesla, P.O- Karmadih, P.S-Jhalda, Dist- Purulia (4) Bablu Mahato S/O Bharat Mahato of Village- Chowk Keruarie, P.O- Torang, P.S-Jhalda, Dist- Purulia (5) Haranath Mahato S/O Lt. Purna Ch. Mahato of Village- Koradih Tola Nowadih, P.O- Torang, P.S-Jhalda, Dist- Purulia.
