Sir,

In producing herewith one arrested accused person namely Nandalal Mahato (54 years) S/o-Late Darku Mahato of Vill- Bartard, PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizure list i.e. 24 (twenty-four) bottles DILKHUSH country sprit each bottle 600 ML with sealed condition and 01 bottle labeled as sample.

I ASI Shibaram Bauri of Joypur PS do hereby lodge a written complaint against the above noted arrested accused person to the effect that on today (09/02/2024) at about 18:05 hrs when myself along with C/-857 Chepual Murmu, C/-181 Rabban Sekh & C/-1358 Sanjib Kumar Patra were performing special raid duty vide Joypur PS C.C. No-441 Date-09/02/2024, as per my source information I reached at Bartard in the shop of Nandalal Mahato under Joypur PS and found that the above noted accused person selling the above noted seized articles in his shop. On seeing Police persons, he concealed his presence at that shop, but on searching we could trace out him and also found the above noted seized articles in his hotel. On being asked he disclosed his name and address. On interrogation he stated that he was selling the said liquor to the local people in Bartard village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such liquor. So it is reasonable to believe that he was selling the said liquor illegally without any documents. So I seized the same under proper seizure list in between 18:55 hrs to 19:15 hrs & labeled the same, duly signed by him and other available witness after taking of 01 piece labeled as sample out of rest seized articles. During further interrogation he confessed his guilt as such I arrested him today 08/02/2024 at 19:20 hrs abiding by all the procedure laid down in Cr.P.C and the latest guidelines of the Apex Court as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Nandalal Mahato (54 years) S/o-Late Darku Mahato of Vill- Bartard, PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
