2.---That on 15-11-2023 accused namely Allizan (Momin) Ansary at about 5.00 to 6.00 P.M. declared in village Hinjuri that he purchased the schedule land from one Chaitu Mahato son of late Mahananda Mahato of village-Kalyanpur (Ghagra) under P. S. Joypur, Dist. Purulia by Registered Sale Deed and he also mutated his name in L.R. Khatian.

It is to mentioned here schedule land is the Homestead land of the complainant and the complainant and his family members also residing thereon.

The complainant on inquiry from the said Chaitu Mahato and witness No.3 who is the attesting witness of the Deed and came to learn that they did not Sale to any property to the Deed and witness No.3 and attesting witness never put any signature to any Deed as witness.

It appears from the alleged Deed and conduct of the accused with the conspiracy with some others prepared this forged instrument and obtained one forged Deed Vide Dec No. 6724/1972 with the intention to wrongful gain by cheating and false personification also.

3.---That on 16-11-2023 the complainant informed the matter to police personal of Joypur P. S. and there after few days the complainant came to learn no case has been started against the accused. Then the complainant informed the matter to S.P. Purulia but off no good. Now for getting appropriate relief the complainant file this case for proper legal action against the accused and this is the caused for delay.
