Sir.

In producing here with 01 (one) arrested accused person namely Joydeb Gorain (30 yrs) S/o-Lankeswar Gorain of Vill-Baragram PS-Joypur Dist-Purulia along with seized articles i.e. 01 (one) Bicycle loaded with approx 2.5 quintal steam coal as per seizure list and submitting a written complaint against the above noted accused person, to the effect that today i.e. 13/02/2024 myself along with C/-2217 Souvik Rana, C/-894 Dhananjoy Mondal all of Joypur PS Dist-Purulia were performing surprise Naka duty at Manakchita border area under Joypur PS vide CC No-482/24 Dated-13/02/2024. During Surprise Naka duty at about 14:45 hrs one Bicycle loaded coal stream was coming from Chandankiyari side under Jharkhand State towards Chas more under Joypur PS. I informed the matter to IC Joypur PS and as per his order, we stopped the Bicycle loaded with coal and found that approx 2.5 quintal steam coal was carrying near Manakchita border area under Joypur PS. On seeing Police persons, he tried to flew away, after hot chase we able to apprehend the above noted person. While running away he fell down and received injury on his forehead. On being asked he disclosed his name and address as noted above. On interrogation he stated that he would sell the illegal coal to local area. On demand he failed to produce any valid papers in respect of possessing selling of steam coal. So, it is reasonable to believe that the bicycle rider collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the bi-cycle transporting steam coal illegally. So, I seized the same under proper seizure list in between 15:05 hrs to 15:25 hrs & label duly signed by witnesses after taking sample of 01 kg steam coal from bicycle. During further interrogation he confessed his guilt and I arrested him today 13/02/2024 at 15:30 hrs as the accused person is liable for violating U/S-379/411/414 IPC. After arrest the accused person namely Joydeb Gorain treated at Joypur BPHC as he received injury during tried to flew away to evade police arrest.

I, therefore pray before you, kindly lodge an FIR against the rider of the bicycle Joydeb Gorain (30 yrs) S/o-Lankeswar Gorain of Vill-Baragram PS-Joypur Dist-Purulia, as per law and arrange for its investigation.
