In producing here with 02 (two) arrested accused persons namely (1) Sanjay Jha (50 yrs) S/o-Late Shyamakanta Jha of Vill-Banshidih PS-Chas Dist-Bokaro State-Jharkhand (2) Ram Kumar Yadab (54 yrs) S/o-Late Mahendra Yadab of Vill-Chandrapur PS-Chandrapur Dist-Bokaro State-Jharkhand along with seized articles i.e. 01 (one) white colour Tata ACE Light Vehicle Goods vehicle heaving Regd. No-JH09K-7795 loaded with approx 18 quintal steam coal as per seizure list and submitting a written complaint against the above noted accused persons, to the effect that today i.e. 22/02/2024 myself along with C/-1389 Debnath Roy, C/-120 Sandip Kumar & C/-2109 Santanu Lohar all of Baglata IC under Joypur PS Dist-Purulia were performing surprise Naka duty at Jala Inter State Border under Joypur PS. During Surprise Naka duty at about 17:55 hrs one white colour vehicle heaving Regd. No-JH09K-7795 was coming from Jala side under Jharkhand State towards Pundag under Joypur PS. We stopped the vehicle and found that the vehicle was loaded with approx 18 quintal steam coal. On seeing Police persons, they tried to flee away, after hot chase we able to apprehend the above noted persons. I also informed the matter to IC Joypur PS. On being asked they disclosed their name and address as noted above. On interrogation they stated that they would sell the illegal coal to local area. On demand they failed to produce any valid papers in respect of possessing selling of steam coal. So, it is reasonable to believe that the driver and his associate collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the driver and his associate transporting steam coal illegally. So, I seized the same under proper seizure list in between 18:15 hrs to 18:35 hrs & label duly signed by witnesses after taking sample of 01 kg steam coal from said loaded vehicle. During further interrogation they confessed their guilt and I arrested them today 22/02/2024 at 18:55 hrs as the accused persons are liable for violating U/S-379/411/414/34 IPC.

I, therefore pray before you, kindly lodge an FIR against the driver namely Sanjay Jha (50 yrs) S/o-Late Shyamakanta Jha of Vill-Banshidih PS-Chas Dist-Bokaro State-Jharkhand and his associate namely Ram Kumar Yadab (54 yrs) S/o-late Mahendra Yadab of Vill-Chandrapur PS-Chandrapur Dist-Bokaro State-Jharkhand, as per law and arrange for its investigation.
