In producing herewith one arrested accused person namely Bhajahari Bagti, (52 years) S/O-Late Nakul Bagti of Vill-Khedatard, PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizure list i.e. 32 (Thirty two) bottles "DILKHUSH" country sprit each bottle 600 ML with sealed condition and 01 bottle labeled as sample.

I ASI Devdeep Mukherjee of Joypur PS do hereby lodge a written complaint against the above noted arrested accused person to the effect that on today (23/02/2024) at about 18:05 hrs when myself along with C/-681 Notan Ch Dey & NVF/696 Shibprasad Singh Sardar were performing special mobile duty vide Joypur PS C.C. No- 604/24 Date-23/02/2024, as per my source information I reached at Forest Check post more in the shop of Bhajahari Bagti under Joypur PS and found that the above noted accused person selling the above noted seized articles in his shop. On seeing Police persons, he concealed his presence at that shop, but on searching we could trace out him and also found the above noted seized articles in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling the said liquor to the local people of Joypur town area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such liquor. So it is reasonable to believe that he was selling the said liquor illegally without any documents. So I seized the same under proper seizure list in between 18:45 hrs to 19:05 hrs & labeled the same, duly signed by him and other available witness after taking of 01 piece labeled as sample out of rest seized articles. During further interrogation he confessed his guilt as such I arrested him today 23/02/2024 at 19:15 hrs abiding by all the procedure laid down in Cr.P.C and the latest guidelines of the Apex Court as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Bhajahari Bagti, (52 years) S/O-Late Nakul Bagti of Vill-Khedatard, PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
