Sir,

In producing herewith the on arrested accused person Meherali Ansari (37 Yrs.), S/O- Ramjan Ansari of Vill- Pundru, Po- Dakakendu, PS- Manbazar, Dist- Purulia (driver of seized vehicle Registration No.-WB 55B /3368) along with one seized vehicle (one Red colour Tractor having Registration No.-WB 55B /3368 Engine No- RLC2MBA1459, Chassis No- MBNABALHLRC00539 attached with red colour Trolley) loaded with sand approx. 100 cft. The fact of the case in brief is that, on 08/02/2024 I along with C/865 Sadananda Murmu and NVF/673 Rabi Sing Sardar all of Kenda PS were performing day mobile duty. During mobile duty on 08/02/2024 at 10:35 hrs when we reached at Kurmasol village near Shib Mandir and found that one red colour tractor with trolley loaded with sand approx. 100 cft was coming from Bordih PS-Manbazar side proceeded towards Kuda village under Kenda PS. On seeing the Police party driver of the said vehicle stopped his tractor with trolley in a distance and he tried to flee away after keeping the tractor at Kurmasole village near shib Mandir but we manage to detain the driver of the said tractor. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor with trolley loaded sand. It ascertained that the owner and driver of the said tractor with trolley loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So I seized the one Red colour Tractor having Registration No.-WB 55B /3368 Engine No- RLC2MBA1459, Chassis No- MBNABALHLRC00539 attached with Trolley without number plate loaded with sand approx. 100 cft. In between 11:05 Hours and 11:35 Hours under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said seized tractor namely Meherali Ansari (37 Yrs.), S/O- Ramjan Ansari of Vill- Pundru, Po- Dakakendu, PS- Kenda, Dist- Purulia, maintaining all formalites of arrest also inform him the ground of the arrest and arranged to inform his relative

Thereafter arrange one driver from my source and brought the tractor No.-WB 55B /3368, with Trolley without number plate loaded with sand approx. 100 cft at Kenda PS. So there have sufficient reason to belief that driver and owner of the said above noted seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver (Meherali Ansari) of the seized vehicle of the red colour Tractor having Registration No.-WB 55B /3368 Engine No- RLC2MBA1459, Chassis No- MBNABALHLRC00539 attached with trolley (red colour) loaded with sand approx. 100 cft
