Most respectfully begs to state:

1. That the Complainant, Accused Persons and the Witnesses are the permanent resident of Village-Kalabani, P.O.-Damda, P.S.- Kenda, Dist.- Purulia, having their respective residential houses therein.
2. That the Complainant has some landed properties at mouza-Kalabani (J.L. No.8) within Kenda P.S. at R.S. Plot No.914 and the Complainant long ago planted more or less 70/75 in numbers Sonajhuri trees therein.

3. That there was no such dispute regarding possession & the Complainant & his family nurturing the said trees.
4. That while such situation going on, the Complainant on 27/12/2023 at about 1.30 P.M. heard that some persons were damaging the trees so planted within R.S. Plot No.914 of Mouza-Kalabani.
5. That on hearing such news, the Complainant rushed to the spot along with the Witnesses No.2 & 3, & found that the Accused Persons out of previous grudge were damaging the trees and all on a sudden the Accused Persons set on fire some Sonajhuri trees.
6. That the Complainant & the Witnesses No.2 & 3 raised protest against the said illegal acts of the Accused Persons when upon the Accused Persons started to abuse them with filthy languages and tried to assault the Complainant & the Witnesses No.2 & 3 with lathi, axe etc. Out of fear the Complainant & the Witnesses No.2 & 3 started hue & cry.
7. That on hearing the hue & cry of the Complainant & the Witnesses No.2 & 3, several persons including the other Witnesses gathered there & on seeing them the Accused Persons fled away.
8. That the Complainant with the help of some persons including the Witnesses, tried to put out the fire & succeeded some how.
9. That due to such fire about 20 numbers of Sonajhuri trees were almost burnt causing loss of about Rs.20000/- of the Complainant.
10. That the Complainant thereafter on went to the O/C Kenda P.S. & inform about the incident & thereafter on several occasions he met the O/C Kenda P.S. inquiring about the steps taken by him against the Accused Persons but the police did not take any action in the matter up-till now.
11. That the Complainant also informed the matter to the S.P. Purulia on 17/11/2024 but up-till now no action has been taken by the police.
12. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Kenda P.S. for investigation & further be pleased to pass necessary order/s.
