Sir,

In producing herewith arrested accused person namely Uttam Kumar Laya (43Yrs) S/o- Lt. Arjun Laya of village- Mohespur, PS-Kenda, Dist- Purulia along with seized articles 1) one white colour jarican containing approx 20 ltrs. ID Liquor under proper seizure list. I, SI Subhash Malik do hereby lodge a written complaint to the effect that today i.e. (23.02.24) at 16.25 hrs during raid duty I received a source information that a person was selling liquor in his house at Mohespur village under Kenda P.S and after receiving such information I, informed the matter to O/C Kenda PS and as per his direction I along with C/807 Santu Howlader and C/808 Soumen Bangal both are of Kenda PS left to work out the information. Accordingly, all of us reached at said place after leaving our vehicle at a safe distance we proceeded on foot to work out the information. At about 17:25 hrs we reached near the P.O and found that above noted accused person was selling something in the cover of darkness at that place. On getting police smell he tried to flee away. On chased we managed to apprehend the above noted accused person. Being examined he disclosed his identity as noted above. During search approx 20 Ltrs. ID Liquor(Cholai) kept in a white colour jarican was recovered from that place. On demand he failed to produce any valid papers/documents in support of processing huge quantity of ID Liquor (Cholai). On interrogation the arrested accused person stated that he was selling huge ID Liquor (Cholia) without any valid papers and by violating the provision laid down in Bengal Excise Act and causing a loss to West Bengal State Excise Department. Accordingly. I seized above noted articles under proper seizure list duly signed by the Police witnesses as well as accused person. No public witness was present at that place at the relevant point of time & collected Approx 500 ml ID liquor (Cholai) in a bottle from the seized jarican as sample and arrested the above noted accused person after maintaining all formalities of arrest.

So, a case may kindly be started against arrested accused person namely Uttam Kumar Laya (43Yrs) S/o- Lt. Arjun Laya of village- Mohespur, PS-Kenda, Dist- Purulia US46A(C) of Bengal Excise Act, 1909 (.) and arrangement may be made for its investigation.
