D. Date of occurrence and section :-

Since January 2020 and onwards Under section 498 (A) I.P.C. and section 3⁴ of Dowry prohibition Act.

The complainant above named begs to state as follows:-

- [1] That accused NO.1 is the husband of the complainant accused No.2 and 3 are the father and mother of accused No.1, and accused No.4 and 5 are the full brother of accused No.1. all the accused persons living in joint mess
- [2] That the marriage of the complainant with accused NO.1 was held on 13/03.2019 in the house of father of complainant at village Goyaladih with in P.S. Kotshila and under the jurisdiction of this court. all religious rits and ceremonies, such as mala-sampradan, Malabadal, Sindurdan chanting of Mantras were gone through or in respect of relatives friends and well wishes of both the parties subsequently marriage was registered under Special Marriage Act. In the said marriage the father of the complainant paid Rs.4,00,000/- through R.T.G.S. and 12 Bharies of Golden ornaments besides utensil, Almirah, dressing table, washing machine, divan etc. and all those articles were given as per demand of the accused persons. All those articles are lying in the custody of the accused persons.
- [3] That after marriage the complainant had been to her matrimonial home and began to stay with accused No.1 as husband and wife.
- [4] That the accused No.1 was in merchant navy so in the month of May 2019, he place of work subsequently the complainant got information that her mother was ill and accordingly the elder brother of the

complainant came to the house of the accused persons and took his sister to village Goyaladih.

[5] That after coming to father house the complainant notice that she was carrying and complainant intimated the said fact to accused No.1. the father of the complainant intimated the said fact to accused NO. 2 and 3 about the pregnancy but the accused persons did not bother. The complainant also send massage and ultimately on 20/01/2020 the complainant gave birth to a female child name Sampriti Das at Kotshila Rural Hospital.

[6] That though intimation was given the accused persons regarding birth of female child but nobody responded from the side of the accused persons. And after 7 days from the birth of the child the accused person no. 2 & 3 came to the father house of the complainant and stay only half an hour and hurriedly left after making some insulting language. After expiry of one month accused No.1 came down at Village -Goyaladih and on the following date the accused No.1 left for Parsudih on the plea that he very much engaged in his works. The accused No.1 did not pay single farthing to the complainant.

[7] That though the complainant requested accused No.1 take her matrimonial home but the accused person did not respond and on 12/07/2022 the elder brother and Boudi both of the of the complainant took her matrimonial home .

[8] That during her stay at matrimonial home the complainant was subjected to torture both physically and mentally at the instance of the accused persons and the accused persons always gave out that insufficient dowry was given in the said marriage and they demanded also cash and kind. The complainant out of fear communicated the said facts to her father and in the last week of July 2022 the father of t he

complainant came down in the house of the accused persons and gave Rs.1,00,000/- in the hand of accused No.3.

[9] That mental and physical torture was so severe which complainant could not afford. Sufficient food and clothing was not given to the complainant even baby food was not given was sucking baby. Accused No.1 after taking liquor in the night used to assault the complainant and the accused persons used to assault the complainant. Due to torture the complainant felt sick, she was compelled to heavy works against is ill-health and the complement was not physically fit due to torture the complainant ultimately intimated the said fact to her father and elder brother and on 27/07/2022 the elder brother of the complainant came to the house of the accused No.1 and took the complainant to village – Gyaladih, initially accused No.1 and 3 did not allow the complainant to accompany her elder brother but the elder brother of the complainant told vaccine such as rubella was required to be given the minor child and on that plea the elder brother of the complainant took her sister. Accused person No.1 and his family members did not keep any information regarding the health of the complainant and her minor child and the accused persons threatened the complainant over cellophane accused No.1 openly gave out in the mobile that if the complainant tried to come down at Namotola i.e. her matrimonial home she should not be allowed to enter, and her life will be serious situation and they will burn her.

[10] That on 14/12/2022 the elder brother of the complainant took to complainant at her matrimonial home and complainant began to stay with her husband but she was again subjected to torture and the said torture was an routine affairs on flimsy ground the complainant was subjected to assault and the accused persons physically assaulted her. Accused No.1 wiped out the vermilion (Sindur) from the forehead of

the complainant. As the complexion of the Complainant is black. So, she was subjected to taunt and accused No.2 and 3 gave out that they will give marriage of accused No.1 with other lady. The complainant bore all those torture with a hope that due to passage of time route behaviour of the accused persons of the charge but ill-luck would have it the said mental & physical torture was increase day by day and the accused persons demanded additional dowry.

[11] That the complainant intimated the said fact to her father and brother and the father of the complainant used to help the complainant financially for purchasing the baby food for her minor child and daily necessity of the complainant. Though the torture was so severe that the complainant ultimately intimated the said fact to her house and on 22/01/2023 the parent of the complainant came down to Namotola i.e. the house of the accuse persons and took her to her father's house.

[12] That when the complainant found that there was no response from the side of her husband and his family members. The elder brother of the complainant on 23/02/2023 took her matrimonial home. But again she was subjected to torture. Accuse No.3 always use to torture the complainant. The complainant belongs to poor family and such family do not match with the family of the accused persons.

[13] That the ill-treatment and torture was so severe that the complainant decided to finish her life by taking poison and /or by strangulation and ultimately on 23/22/2023 accused persons openly gave out that they will not keep and maintain the complainant and accused No.3 intimated the said facts to the father of the complainant. The accused persons also tried to set fire to the complainant but she however grace of god rescued herself.

[14] That ultimately on 23/11/2023 the father and brother of the complainant went to Namotola and took the complainant. They were

also were also insulted at the hands to house of the accused persons. The accused persons give not a single sum to the complainant and since 23/11/2023, the complainant has been staying at her father's house.

[15] That the complainant on 15/12/2023 the complainant intimated the said facts to the Officer-in-charge Kotshila P.S. by Regd. Post with Ack. due as no response was given. So on 08/01/2024 complainant lodge intimation to Superintendent of Police Purulia.

[16] That the accused persons have committed an offence under section 498 A I.P.C. and under section 3 of Dowry Prohibition Act. witness are aware about the entire incident.

[17] That the complainant is a poor lady and she is not in a position to prosecute the case in her personal capacity for which the complainant invokes the provision Under section 156 (3) Cr. P.C.

[18] That the complainant is a neglected wife and she is the victim of torture (physically and mentally, ill-treatment , harassment and dowry prohibition).

It is prayed that your Honour may graciously be pleased to direct the Officer-in-charge Kotshila P.S. to start a case against the accused persons, by treating this petition as complaint of F.I.R. as provided under section 156 (3) Cr.P.C.
