Sir.

I ASI Janardan Kumar of Kotshila PS, Dist- Purulia producing herewith one arrested accused person namely Chasha Hembram (26 yrs) S/O-Lt. Rabi Hembram of Vill-Bararola, PS-Kotshila, Dist-Purulia along with seized articles i.e. (1) One white colour jarican containing approx 16 Ltrs. ID Liquor (Cholai) (2) Approx 500 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (09.02.2024) during evening mobile duty vide Kotshila PS C.C No. 418/2024, Dated 09.02.2024 acting upon a secret source information myself along with C/2242 Dinesh Ch. Kar and C/633 Dasarath Sing Mura both are of Kotshila PS conducted raid in the house of accused person Chasha Hembram at about 17:15 hrs and found that the above noted person was keeping and selling of ID liquor (Cholai) to the others in his own house. Seeing the Police party. he tried to flee way but we managed to apprehend the above noted accused person. On being asked he failed to produce any valid license / documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 16 Ltrs. ID Liquor 2) Approx 500 ml ID liquor (Cholai) as sample which was collected from seized articles from SI No- 01 & kept in a bottle in his possession under proper seizure list in presence of witnesses and duly signed by them at 17:25 Hrs and 17:55 Hrs and also arrested the above noted accused person at 18:05 hrs after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Chasha Hembram (26 yrs) S/O-Lt. Rabi Hembram of Vill-Bararola, PS- Kotshila, Dist-Purulia under proper section of law.
