Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sanatan Mahato, S/O- Shyamapada Mahato, of Village- Bamni, P.O- Bamni, P.S.- Manbazar, Dist - Purulia, has committed unauthorise use of Electricity U/S 138(b) of the Electricity (Amendment) Act-2007.

On dated 05.02.2024, at about 10:45 AM ,I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with, Sri Santu Dhali, J.E(E), Manbazar CCC & Sri Asit Baran Kundu, J.E(E), Manbazar CCC, WBSEDCL entered the premise of Sanatan Mahato, S/O- Shyamapada Mahato, Dist – Purulia and inspected his premise and found that he was using electicity by reconnecting his disconnected service line (Consumer id-201127371) unauthorisely.

During inspection, it was found that he was using electricity dishonestly U/S 138(b) was detected. An incandescent lamp of 200 watt is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11:05am on dated 05.02.2024. The accused person has committed an offence U/S 138 (b) of the Electricity (Amendment) Act-2007.

The service connection has been disconnected on 05.02.2024. You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
