Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Chandan Mukherjee**, **S/O- Sri Amiya Mukherjee**, a permanent resident of **Vill- Kochbel**, **P.S -Neturia**, **Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **08.02.2024** at about **03:25 PM** I, Sri Dhritiman Sardar S/O- Sri Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Partha Chakraborty, DE (S&LP) Purulia Region, Sri Dayamay Mahato Sr. TSH of Purulia Region S & LP Unit, Sri Souvik Mudi, J.E. (Gr-II), Satya Rajwar Sr. TSH, both attached to Saltore CCC and others had been to the village Kochbel for routine inspection purpose. During inspection it was detected that **Sri Chandan Mukherjee** was consuming electricity dishonestly and unauthorisedly in his commertial premises by the way of direct hooking for from the nearby LT mains of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load **02.01 KVA**.

As theft of electricity was detected during inspection the illegal hooking line is disconnected & removed from the nearby electrical source and two core PVC allumium wire of black colour approx 06 meter route length along with hooking devices has been seized under memo of seizure list in the presence of witnesses but the accused person denied to sign on the Inspection Report and seizure list. The above seized materials duly packed and labeled at the inspection site but the accused person refrain to sign for the same. The inspection team left the aforesaid premises at about **03:50PM**.

Thus the accused **Sri Chandan Mukherjee**, **S/O- Sri Amiya Mukherjee**, **Vill-Kochbel**, **P.S -Neturia**, **Dist- Purulia** have committed an offence **u/s 135(1)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
