Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Subal Ghoroi (52 yrs) S/O- Sudhir Ghoroi of Vill-Rangdih, PS-Neturia, Dist-Purulia with seizure of 14 pcs sealed bottles of Dil Se Country spirit containing 600 ml each (MRP @ Rs. 55/-) which were seized under proper seizure list.

I beg to submit that today (09.02.2024) while I, ASI Manik Chandra Mahato, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-413 Dt. 09.02.2024 & CC No-436/24 Dt. 09.02.24 and acting on source information after consulting you at about 18:05 hrs reached at village Rangdih and held raid in the house of Subal Ghoroi (52 yrs) S/O- Sudhir Ghoroi of Vill-Rangdih, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act.1909 and he was arrested U/S-67 BE Act and also 14 pcs sealed bottles of Dil Se Country spirit containing 600 ml each (MRP @ Rs. 55/-) which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Subal Ghoroi (52 yrs) S/O- Sudhir Ghoroi of Vill-Rangdih, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/174 Tapandas Bauri (2) C/1550 Bharat Ghosh and (3) NVF/487 Kirtan Singh Sardar all of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Subal Ghoroi (52 yrs) S/O- Sudhir Ghoroi of Vill-Rangdih, PS-Neturia, Dist-Purulia under proper section of law.
