In Producing here with one arrested accd. Person namely Ganesh Kumbhakar aged 48 years. S/O Ramgoti Kumbhakar of Vill. Baghardanga, P.S. Neturia Dist. Purulia brought under arrest with seized article 01(One) white coloured plastic jar cane containing approx 10 (Ten) Ltrs of I.D. Liquor from his possession. I do hereby lodged this written complain to the effect that on-18/02/24 I was engaged anticrime evening mobile duty along with 1) C/564 Prasad Majhi & 2) NVF/1051 Biswajit Mahato both of Neturia PS vide Neturia PS CC No- 519/24dated-18/02/2024.During mobile duty I received telephonic source information that one person selling I.D. Liquor at Baghardanga Village in lieu of money. I inform the matter to O/C Neturia P.S over phone as per his direction myself along with force left for Baghardanga to work out the information. We reached at Baghardanga Village at about 18.05 hours and held raid in the house of Ganesh Kumbhakar S/O Ramgoti Kumbhakar of Vill. Baghardanga, P.S. Neturia Dist. Purulia and found one person was selling ID liquor in lieu of money . On search I found 01(One) white plastic jar cane containing approx 10 (Ten) Ltrs of I.D. Liquor at his room. On Interrogation he stated that he use to sale the I.D. Liquor in lieu of money for his illegal gain. On demand he also failed to produce any valid challan / Papers in respect of I.D. Liquor. Hence he violated the provision of 46 A (c) of B.E. Act.

Accordingly I seized the 01(One) white plastic jar cane containing approx 10 (ten) Ltrs of I.D. Liquor from the possession of Ganesh Kumbhakar S/O Ramgoti Kumbhakar of Vill. Baghardanga, P.S. Neturia Dist. Purulia after preparing proper seizure list duly signed by the accd. person and witnesses then I arrested accd. Ganesh Kumbhakar 48 years S/O Ramgoti Kumbhakar of Vill. Baghardanga, P.S. Neturia Dist. Purulia and prepared arrest memo. I took 500 ml of ID Liquor out of 10 Ltrs as sample and prepared proper label of both seized articles duly signed by the accd. person and witnesses. I search for local public witnesses but found none.

Person in the Lock UP after maintaining all formalities and submitted this written complain before you to start a case against Ganesh Kumbhakar S/O Ramgoti Kumbhakar of Vill. Baghardanga, P.S.
