Sub:- Complain for starting a specific case .

Sir,

In producing herewith seized 01 (one) Tractor bearing registration No. WB 82E/2251 (Make- POWERTRAC 439 RDX), Chassis Serial No- T053547972AK, Engine Serial No- E3615134 along with trolley loaded with sand 100 CFT (approx) under proper seizure list with arrested accused Rabin Chandra Mallick (30 yrs) S/O- Lt. Kalipada Mallick of Vill- Mejhardih, Kenaidih, PS-Santuri, Dist-Purulia (Driver of tractor No-WB 82E/2251). I beg to submit that I, SI Sujan Ghosh along with (1) C/1568 Debojyoti Sinha (2) C/753 Shyamsundar Mahato and NVF/176 Phakir Ch. Pal were performing day mobile duty vide Neturia PS GDE No- 1038 Date 23.02.2024 & CC No- 588/24 Date 23.02.2024 at Subhas More on surprise Naka Checking under Neturia PS area. At about 15:05 hrs received credible source information that one tractor bearing registration No. WB 82E/2251 (Make- POWERTRAC 439 RDX) loaded with illegal sand in trolley coming from Harmardih side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force at about 15:25 hrs found that above noted tractor was coming from Harmardih village side and suddenly the driver stopped the tractor near to Naka checking point and after seeing the police party, he got down from the tractor and started to run towards the village area. We chased to apprehend the driver and succeeded to apprehend him. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded sand but he failed to produce any valid documents in support of loaded sand as well as the vehicle and also his driving licence. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner have procured said sand from illegal Ghat. Then we searched the tractor and found that the vehicle (tractor) having registration No. WB 82E/2251 (Make- POWERTRAC 439 RDX) loaded with sand in Trolley approx 100 CFT.

So, there is reason to believe that the driver and registered owner of the above noted tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner knowing it to be stolen.

Accordingly, I seized the tractor having registration No. WB 82E/2251 (Make- POWERTRAC 439 RDX) along with trolley loaded with sand approx 100 CFT (approx) in between 15:30 hrs and 15:50 hrs. under proper seizure list duly signed by witnesses and then arrested the above noted tractor driver at 15:55 hrs. So, the driver and registered owner of the above noted tractor have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against Rabin Chandra Mallick (30 yrs) S/O- Lt. Kalipada Mallick of Vill- Mejhardih, Kenaidih, PS-Santuri, Dist-Purulia (Driver of tractor No-WB 82E/2251) and registered owner of tractor having registration No. WB 82E/2251 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
