Sub:- Prayer for lodging F.I.R.

Sir,

In producing herewith 01 (one) arrested accused person namely Pradip Mahato (32 Yrs) S/o Bijoy Mahato of Vill- Agardih, PS- Kashipur, Dist- Purulia along with seized Truck bearing No-WB45/5874 loaded with sand approx 700 cft. under proper seizure list, I beg to submit that on 04.02.2024 I along with 1) C/1111 Ragda Mandi and 2) C/862 Debdas Karmakar of Anara OP under Para P.S were performing Mobile duty vide Anara OP under Para PS CC No-233 Date-04.02.2024. During my mobile duty at about 03.05 hrs. on 05.02.2024 myself along with force reached at Dhagora Village More under Para PS and found that a Truck having Regd. No-WB45/5874 loaded with sand was coming from Kashipur side. On seeing the Police party at Dhagora Village More, the driver of the said Truck was trying to flee away. But after a hot chase, we could able to detain the driver of said truck having No- WB45/5874. I asked the driver Pradip Mahato to produce valid documents in respect of said sand and vehicle but he informed that the documents in respect of said sand and vehicle were kept with the owner. So the owner of the said truck has been informed to produce the documents. The driver and the sand loaded truck have been detained at Anara OP vide Anara OP G.D.E. No- 63 Dtd-05.02.2024. Nobody came to PS to produce any documents regarding lifting & transportation of sand as well as vehicle till 13.00 hrs. Finding no other alternatives I further interrogated him thoroughly. During interrogation, the driver admitted that they were dealing with illegal sand lifting from Dwarkeswar river bed and transporting the sand to Purulia District area. The owner of the said truck was also involved in this illegal lifting and transportation. Hence, I seized the truck having bearing Regd. No- WB45/5874 loaded with sand in between 13.35 hrs to 14.05 hrs under proper seizure list maintaining all legal formalities and I also arrested Pradip Mahato (32 Yrs) S/o Bijoy Mahato of Vill- Agardih, PS- Kashipur, Dist- Purulia after maintaining all legal formalities regarding his arrest. This refers to Anara OP under Para PS G.D.E. No- 77 Dtd- 05.02.2024. I brought the said sand loaded truck to Para P.S. compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive are dealing with sand illegally and transport to Purulia District area without any valid document. So they are liable for offence punishable under the purview of law.

Therefore, I pray before you that a case against namely Pradip Mahato (32 Yrs) S/o Bijoy Mahato of Vill- Agardih, PS- Kashipur, Dist- Purulia and Owner of truck having bearing Regd. No- WB45/5874 may kindly be started and arrange for its investigation.
