Sekh Tabir, S/O Late Samsul, 3. Samdul Haque, S/O Late Sayed, 4. Sekh Himmad, S/O Late Sekh Khuyaji and 5. Sekh Alamgir, S/O Sekh Rafik, Residents of Vill – Hariharpur, Sankra B, P.S. Para, Dist- Purulia for verbal and physical assault on wbsedcl contractual outsourcing staffs during outstanding revenue collection at Sankra B village. Today (06.02.2024) in between 1:00 p.m. and 1:30 p.m., Sri Ujjwal Mondal of M/S Unit Electric, Chinmay Bauri, Prabesh Mahato, Chandi Charan Mahato of M/S Power Tech, Sanjoy Gorain, Kajal Majee of M/S Bright Construction, Ashok Mahato, Prakash Chandra Mahato of M/S Sharat Construction all staffs of different agencies enlisted under WSEDCL were on a general outstanding revenue collection work at Sankra B village, when the above mentioned persons obstructed the WSEDCL representatives from doing their assigned job. During the said work above mentioned miscreants started abusing the outsourcing staffs of WSEDCL and they also started beating them with their hand.

The outsourcing staffs submitted written complaint to the undersigned for the above matter.

This incident effects all the work and services of WSEDCL under Sankra B village, as the incident is causing fear among the staffs to work at the village in future.

So, you are requested to treat this complaint as F.I.R.
