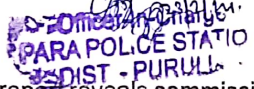

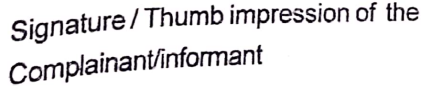

Respected Sir,

In producing herewith one arrested accd. person namely Judhishtir Rajwar (56 Yrs) S/o Lt. Shatrughna Rajwar of Vill-Madhabpur, PO-Tentulda, PS- Para, Dist- Purulia with seized article i.e 19 (Nineteen) Pcs. sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (23.02.2024) during my Evening Mobile duty I received credible source information that one Judhishtir Rajwar (56 Yrs) S/o Lt. Shatrughna Rajwar of Vill-Madhabpur, PO-Tentulda, PS- Para, Dist- Purulia has stored huge quantity of Country Spirit for selling. Accordingly, I informed to O/C Para PS and as per his instruction in between 18.35 hrs to 18.55 hrs. I held raid in the house of Judhishtir Rajwar (56 Yrs) S/o Lt. Shatrughna Rajwar of Vill-Madhabpur, PO-Tentulda, PS- Para, Dist- Purulia and found that the above noted person was keeping/selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for keeping/selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit. As such he committed offence/46A(c) BE Act 1909 so he was arrested on 23.02.2024 at 19.25 hrs. U/S 67 BE Act and also seized 19(Nineteen) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were kept in his house in which 01 (one) bottle as sample under proper seizure list in presence of witnesses duly signed by them. I prepared seizure list and label in presence of witnesses duly signed by them. During the time of arrested maintaining all rules and guideline as laid down by NHRC/WBHC and informed his family members.

The arrested accd. namely Judhishtir Rajwar (56 Yrs) S/o Lt. Shatrughna Rajwar of Vill-Madhabpur, PO-Tentulda, PS- Para, Dist- Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a specific case may kindly be started against Judhishtir Rajwar (56 Yrs) S/o Lt. Shatrughna Rajwar of Vill-Madhabpur, PO-Tentulda, PS- Para, Dist- Purulia under proper section of law.
