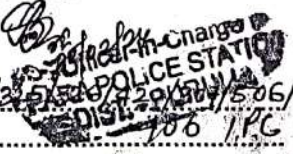

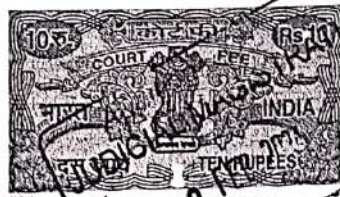

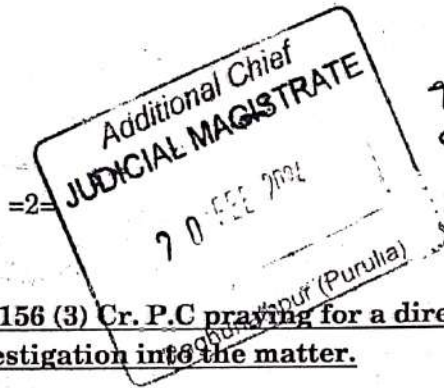

An application under section 156 (3) Cr. P.C praying for a direction upon O.C, Para P.S for causing investigation into the matter.

The complainant named above most respectfully beg to state as follows :-

That the your petitioner Daizy Prasad Lala, W/O Lt. Ratan Kumar Lala is a permanent resident of Vill:- Shyampur, P.O-Anara R.S, P.S-Para, Dist:- Purulia which is within the jurisdiction of this Id. Court.

That your petitioner and her husband are peace loving and law abiding citizen.

That Ladly Yadav, D/O Ramasarai Yadav is also a resident of their locality and she works as a mediator or agent of different company on tariff of commission.

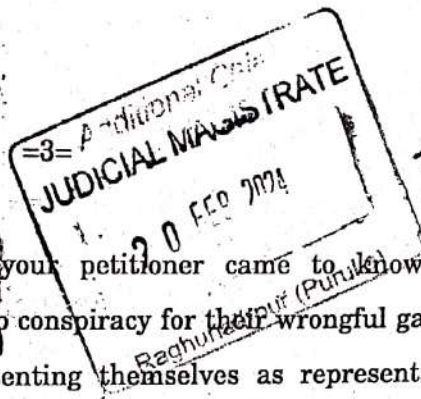
That the complainant Daizy Prasad Lala had acquaintance with said Ladly Yadav who made assurance for supplying the Membership of Tines Distributor of a Medicated product and Accessories in the name of her husband and for which she had to pay a sum of Rs. 5,39,000/- and accordingly your petitioner paid her said amount by issuing three cheques on three occasion.

That your petitioner issued a cheque of State Bank of India of Rs. 4,00,000/- on 20.11.2021 in favour of said Ladly Yadav, thereafter she again issued another cheque of Rs.1,00,000/- on 24.11.2021 and lastly she issued a cheque of Rs.39,000/- on 18.05.2021 in favour of said Ladly Yadav which she made en-cashment in her account.

That thereafter Ladly Yadav provides a Membership Card of Tines Distributor in the name of your petitioner's husband being Membership No. 76511473 but in spite of paying such an amount Rs. 5,39,000/- her husband did not get any Medicated Product of Tines Distributor.

That in spite of paying such huge amount of Rs.5,39,000/- her husband did not get any Medicated Product of Tines Distributor and for which your petitioner approached before the accused for supplying those Medicated Product but the accused did not care for it.

That Since some time past your petitioner came to know that some unscrupulous persons have hatched up conspiracy for their wrongful gain and some persons with ill motive were representing themselves as representative of the aforesaid companies and all on a sudden the petitioner received bolt from blue when the petitioner came to learn that the accused person by practicing fraud collected Rs.5,39,000 against a product of the company and that apart the accused person has also collected money against another product of the company.

That the it may be mentioned here that the accused person is no way legally connected with the aforesaid company as such she does not have any legal right to collect money for product of the company nor does she has any right to transfer and / or assign any product of the company.

That on getting information of such illegal and high handed activities your petitioner started to gather information and during query your petitioner came to know that the aforesaid accused person entered into criminal conspiracy with each other for their wrongful gain and for causing wrongful loss to the petitioner and their company.

That thereafter your petitioner several times requested said Ladly Yadav for returning of the said amount of money as her husband did not get any Medicated Product of Tines Distributor but she did not take any step to return of her money.

That it is pertinent to mention here that thereafter the husband of your petitioner expired on 30.09.2022 and for which your petitioner had to suffer great financial problem. So your petitioner again met with Ladly Yadav and asked for returning her money but she did not return her.

That your petitioner ventilated her grievance before Superintendent of Police, Purulia and District Magistrate on 13.12.2023 but no action has been taken.

That thereafter on 01.02.2024 at around 7-00 p.m when said Ladly Yadav was proceeding through the house of your petitioner, she met with said Ladly Yadav and demanded her money which she paid to her then at that time said Ladly Yadav started to throw abusive and filthy language upon her and when your petitioner raised protest, she pounced upon her and tried to kill her by throttling. Hearing shouting when the mother of your petitioner Ramabati Prasad rushed to the spot to save her then said Ladly Yadav started to assault her mother by catching her hair and dashed her against the ground and she also assaulted her mother by fist and blows.

That the entire incident took place in presence of the witnesses and when the local people came in rescue, she fled away from the spot.

That for such assault upon the petitioner and her mother both sustained pain and injury on their person and both of them were medically treated by Dr. A.K. Hazari (Medical Document is attached here).

That the miscreant named above threatened the complainant and his family members with dire consequences saying that if the matter is reported before any authority then she would do away with the life of her and her family members.

That after gathering courage the complainant went to Para Police Station and ventilated her grievance on 01.02.2024 but no action has been taken.

That thereafter again the matter has been reported to the Superintendent of Police, Purulia on 02.02.2024 but till date no case has been started regarding the aforesaid incident as the miscreant has political influence.

That the accused person has committed the offence under sections 323 /324 / 325 /326 /420/307 / 506 of IPC.

That the complainant is a poor person and has no any sufficient means to bear expenses of this case for which the complainant seek justice.

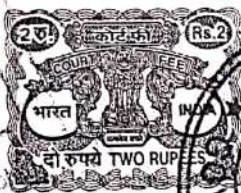
That a through investigation is required by a specialized agency for unearthing the truth otherwise truth would not see the light of the day.
