Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Meghnath Kuiri (46 Yrs) S/o- Lt. Maruti Kuiri of Vill- Bhul, PS- Purulia (M), Dist- Purulia and seized articles 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S, each containing 600 ml along with seizure list.

I beg to state that today (09.02.2024) while I along with force (i) C/178 Tulsi Mahato (ii) HG/ 1618 Haripada Gorain both of Purulia (M) PS vide GDE No- 462 Dtd. 09.02.2024 were performing mobile duty, at about 15:05 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors in a grocery shop at Bhul village. Subsequently, I informed the matter to you and as per your direction, I along with force rushed to the spot at Bhul village and after arriving at the spot and as per your instruction we conducted raid in the 'Grocery shop situated at Bhul village under this PS. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Meghnath Kuiri (46 Yrs) S/o- Lt. Maruti Kuiri of Vill- Bhul, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the illegal liquors in his shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle were taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 15:40 & 15:55 hrs.

Accordingly, I arrested the involved accused person namely Meghnath Kuiri (46 Yrs) S/o- Lt. Maruti Kuiri of Vill- Bhul, PS- Purulia (M), Dist- Purulia at 16:05 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Meghnath Kuiri (46 Yrs) S/o- Lt. Maruti Kuiri of Vill- Bhul, PS- Purulia (M), Dist- Purulia under proper section of Law.
