Reasons for delay in reporting by the complainant/informant:
Particulars of properties stolen/involved: Seized 17 (seventeen) sealed bottles C/S style on T. Siddheshwar each containing 600 ml out of which one (one) bottle taken as sample.
Contents: The original written Complaint of case attached here.

Offence taken: Since the above report reveals commission of offence(s) w/s 46 A (c) of Bengal Excise Act 1909.

Registered the case and took up the investigation/directed by Sd. Khageswar Ghosh, PS. to take up the investigation/transferred to P.S. on point of jurisdiction. FIR read over to complainant/informant, admitted to be correctly recorded and a copy given to the Complainant/Informant free of cost.

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Siddheswar Gorain (36 Yrs) S/o- Rashon Gorain of Vill- Bhul, PS- Purulia (M), Dist- Purulia and seized articles 17 (Seventeen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (12.02.2024) at 17.35 hrs I, SI Mekdam Sabab of Purulia (M) PS received a secret tip off an illegal possession of a huge quantity of liquors in a house of Bhul village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/248 Arabinda Roy (ii) C/- 1350 Subodh Kr. Bauri both of Purulia (M) PS vide GDE No- 668 Dtd. 12.02.2024 rushed to the spot i.e. Bhul village at 18.55 hrs. After arriving at that spot and as per your instruction we conducted a raid in a house situated at Bhul village under this PS. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Siddheswar Gorain (36 Yrs) S/o- Rashon Gorain of Vill- Bhul, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his house for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle were taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between at 19.05 hrs.

Accordingly, I arrested the involved accused person namely Siddheswar Gorain (36 Yrs) S/o- Rashon Gorain of Vill- Bhul, PS- Purulia (M), Dist- Purulia at 19.35 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Siddheswar Gorain (36 Yrs) S/o- Rashon Gorain of Vill- Bhul, PS- Purulia (M), Dist- Purulia under proper section of Law.
