Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Prankrishna Gope @ Fulchand Gope S/o- Lt. Shibaram Gope of Vill- Shyampur, PO- Nadiara, PS- Purulia (M), Dist-Purulia and seized articles 19 (Nineteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (12.02.2024) at during special raid duty at about 19.15 hrs I, SI Abhijit Singha of Purulia (M) PS received a secret tip off an illegal possession of a huge quantity of liquors in a shop near Sainik School morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/248 Arabinda Roy (ii) C/- 1350 Subodh Kr. Bauri both of Purulia (M) PS vide GDE No- 668 Dtd. 12.02.2024 rushed to the spot i.e. Bhul village at 19.55 hrs. After arriving at that spot and as per your instruction we conducted a raid in the shop (GUMTI) situated near Sainik School morh under Purulia (M) PS. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Prankrishna Gope @ Fulchand Gope S/o- Lt. Shibaram Gope of Vill- Shyampur, PO- Nadiara, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his shop (GUMTI) for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 19 (Nineteen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle was taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 20.05 & 20.15 hrs.

Accordingly, I arrested the involved accused person namely Prankrishna Gope @ Fulchand Gope S/o- Lt. Shibaram Gope of Vill- Shyampur, PO- Nadiara, PS- Purulia (M), Dist-Purulia at 20.25 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Prankrishna Gope @ Fulchand Gope S/o- Lt. Shibaram Gope of Vill- Shyampur, PO- Nadiara, PS- Purulia (M), Dist-Purulia under proper section of Law.
