Sub: Prayer for lodging FIR under proper section of law.

Sir,

In producing herewith the seized vehicle one Red Colour Tractor (Mahindra B 275DI) having Reg. No- WB 55A 8848 attached with a Trolley, loaded with sand approx 100 cft and Seizure list.

I beg to state that on 12.02.2024 myself along with force (i) C/- 1137 Sridam Bauri & (ii) C/- 982 Shyamal Rajwar both of Purulia (M) PS left for evening night mobile duty vide Purulia (M) PS GDE No- 666 Dtd. 12.02.2024 at PS area. Today (13.02.2024), at about 05.05 hrs, I received an information from source that a suspicious tractor loaded with sand was coming from Bhul Ghat (Kasai River). Accordingly, I informed the matter to you and as per your kind directions, I along with force proceeded towards that place to work out the information. While I, along with the force, arrived at Baghudih village area under Purulia (M) PS at about 06.05 hrs we found 01 (One) Red colour Tractor attached with a trolley loaded with sand standing at that place. Accordingly, I along with the force intercepted the vehicle one Red Colour Tractor (Mahindra B 275DI) having Reg. No- WB 55A 8848 attached with a Trolley, loaded with sand approx 100 cft without a driver or any other person I found that the vehicle as well as goods identical as I received prior information. I moved through the surrounding area to trace the said driver or owner of said detained tractor, but nobody was found to stand its ownership. During primary enquiry it was found that the owner and driver of the said vehicle (Tractor) loaded the said sand by illegal means to sell the same to make their own profit by dishonestly and they had been running a clandestine business. It is reasoned to believe that the driver in cahoots with the owner of the vehicle and others procured the said sand from the Kansai River under Purulia (M) PS side by fraudulent means or theft by any means to transport the same to run a clandestine business.

Accordingly, finding no other alternative way I seized the vehicle one Red Colour Tractor (Mahindra B 275DI) having Reg. No- WB 55A 8848 attached with a Trolley, loaded with sand approx 100 cft under proper seizure list. The seizure was made in between 06.15 & 06.35 hrs in presence of the available witnesses duly signed by them. Thereafter, I brought the said seized Tractor (Mahindra B 275DI) having Reg. No- WB 55A 8848 to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the owner and driver of the seized vehicle Red Colour Tractor (Mahindra B 275DI) having Reg. No- WB 55A 8848 attached with a Trolley, loaded with sand approx 100 cft under the proper section of Law.
