Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(e) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 06/02/2024 at 14.40 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with Partha Chakraborty (DE S&LP attached to Purulia Regional Office WBSEDCL), Promod Ranjan Barman (Special officer attached to Purulia Regional Office, , Anurag Pandey (OE attached to Purulia CCC), Sanjoy Kumar Mahato (Sr TSH attached to Purulia CCC) and Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) and Tarapada Hazari along with 2 other police officials went to make an inspection to workout upon a source information regarding theft of electricity at the premises of Rajib Banerjee, Son of Anil Kumar Banerjee, resident of N.C. Dagupta Road, Purulia (T) Thana , Dist Purulia by serving one entry notice which was signed by consumer representative.

One complaint against the same Rajib Banerjee, Son of Anil Kumar Banerjee, resident of N.C. Dagupta Road, Purulia(T) Thana, Dist Purulia was lodged at Purulia(T) PS for theft of electricity U/S 135 1(b), 1(c) & 1(d) of the electricity Act 2003, Amendment of 2007 vide FIR no 03/24 dt 04.01.2024 and the service line serving electricity to the domestic premises of Rajib Banerjee was disconnected on 04.01.2024.

During inspection the inspection team has faced strong resistance from Rajib Banerjee for entering into the premises and inspection and he also misguided the inspection team.

During the time of inspection at the premises 1 nos of electricity meter was found having serial no G154236 (Consumer id 242232120, Consumer Name-Ruma Basnab (Roy)).

It was observed that user Rajib Banerjee has made unauthorized use of electricity under section 135 1(e) by extending the service connection vide consumer ID 242232120 in the name of Ruma Basnab(Roy), which was supposed to serve electricity to the rent out premises other than the domestic premises of Rajib Banerjee in the same building. From the above arrangement the accused was using 7 ampere single phase power at 220 volt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service lines in the premises from pole with the help of LT Mobile Van Team but due to strong resistance and considering the heat of the moment inspection team could not cut and seize the interconnecting red wire which was used to use electricity at the domestic premises of Rajib Banerjee. Inspection team prepared inspection related documents in front of the local witness and Rajib Banerjee who refused to put their signature on the inspection related documents.

The inspection team left the premises at about 17.12 Hrs on 06th February 2024.

The accused committed theft of electricity U/S 135 1(e) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
